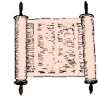

## THE NET OF THE NEW WORLD ORDER REVEALED!

*I had barley finished the previous article, particularly focusing on the number 153, when my attention was drawn to the plans of the UN 2030 agenda. I just had to include this follow up article in this magazine. It is amazing how Yahweh helps to bring things together in such a timely fashion!*

Where are we in the Scriptural history of the world? We know that there were to be four world ruling kingdoms spawned from the Great Sea which is what the Mediterranean Sea was called anciently. According to Yahweh Who inspired Daniel to write his prophecies, there were to be four kingdoms that were to be ruling the Mediterranean area, especially the area around Jerusalem and the land of Canaan. They were Babylon, Medo-Persia, Greco-Macedonia, and Rome.

Yahweh issued a special prophecy to Belshazzar of Babylon in chapter five of the book of Daniel, “<sup>1</sup>Belshazzar the king made a great feast to a thousand of his lords, and drank wine before the thousand. <sup>2</sup>Belshazzar, while he tasted the wine, commanded to bring the golden and silver vessels which his father Nebuchadnezzar had taken out of the temple which was in Jerusalem; that the king, and his princes, his wives, and his concubines, might drink therein. <sup>3</sup>Then they brought the golden vessels that were taken out of the temple of the house of Yahweh which was at Jerusalem; and the king, and his princes, his wives, and his concubines, drank in them. <sup>4</sup>They drank wine, and praised the elohim of gold, and of silver, of brass, of iron, of wood, and of stone. <sup>5</sup>In the same hour came forth fingers of a man's hand, and wrote over against the candlestick upon the plaister of the wall of the king's palace: and the king saw the part of the hand that wrote. <sup>6</sup>Then the king's countenance was changed, and his thoughts troubled him, so that the joints of his loins were loosed, and his knees smote one against another,” Dan. 5:1-6.

He called for all of his astrologers, soothsayers, and Chaldeans to interpret the message, but none could even begin to interpret it. Finally, he

was persuaded by his mother to call for Daniel who interpreted it for him. The message read “Mene, Mene, Tekel, Upharsin. Daniel interpreted it as, “<sup>26</sup>This is the interpretation of the thing: MENE; Elohim hath numbered thy kingdom, and finished it. <sup>27</sup>TEKEL; Thou art weighed in the balances, and art found wanting. <sup>28</sup>PERES; Thy kingdom is divided, and given to the Medes and Persians,” vv. 26-28.

This prophecy was not only for Belshazzar's immediate kingdom, but it was also for the succession of kingdoms down to the end of the age.

The image that Nebuchadnezzar was shown had a head of gold, breast and arms of silver, belly and thighs of brass/bronze, legs of iron, feet of iron and potter's clay, and toes of iron and miry clay. This was not only a thumbnail sketch of the history of the succession of the earthly world ruling kingdoms, but also a thumbnail sketch of the history of idolatry. The head of any body is always the body's control center, so the successive kingdoms followed their head (Babylon) in her idolatrous ways.

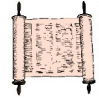
Daniel 7 reveals the beastly nature of the kingdoms while Daniel 8 is a dialogue and prophecy of the eastern half of the Roman Empire (the two legs represented the division between east and west).

The message in Daniel 5 was not only the message about the instantaneous end of the first kingdom of Babylon, but also about the demise of the final kingdom of Rome. The whole kingdom (body from head to foot) was to remain intact until the latter years.

A deeper interpretation reveals the end of the fourth kingdom as a kingdom of order to the final system of disorder because of the iron and

miry clay of the toes. The iron of the legs typified the Roman kingdom and her rule in power. Then the feet become iron and potter's clay. While iron and clay don't mix and bond very well, the potter's clay, while fragile, does hold its form quite well as pottery has been utilized for certain cups, bowls, images, etc. for millennia. But miry clay has no ability to be formed into anything. It has lost any form. Look at the minds of those who are demanding socialism in today's world. They want to destroy any kind of order, no police force, no laws, no stability. They want to destroy history to the point that the people live in total absolute ignorance, and they especially want to belittle and destroy the Scriptures so that there is no great spiritual power to answer to.

MENE, MENE, TEKEL, UPHARSIN was also a prophecy of the end of the Roman kingdom under the leadership of her heads, the Caesars! It is a key to understand when the end times began and how. In reality they are apportions. MENE is equivalent to fifty (50) shekels, the TEKEL was equivalent to one (1) shekel, and UPHARSIN was equivalent to one-half MENE or twenty-five (25) shekels. A shekel consisted of twenty (20 gerahs), therefore we have  $126 \text{ shekels} \times 20 = 2520$ .

The kingdom of Babylon came to reality around 612 BCE when they overthrew the Assyrian Empire and destroyed their ruling city of Nineveh. But they didn't achieve world ruling status until they invaded Judah and subjugated their king and chief city Jerusalem. This took place in 607-603 BCE. Let's subtract 607-603 from 2520 to see what the result will be:  $2520 - 607 - 603 = 1913 - 1917$ . Adding 1 for the year 0 the result is 1914-1918.

This is the event of the "Great War" when both of the eastern and heads of the end time Roman Empire fell. The Russian Czar (Caesar) was overthrown and destroyed in the east by socialistic Communistic forces while the western Kaiser (Caesar) of Germany was overthrown by the west-

ern allied forces. This ended the empowerment of the god-king Caesars over their kingdom and government of the Roman Empire. This ended the periods of iron, and iron and potter's clay and began the time of the iron and miry clay.

The Caesars were the lawmakers typifying the iron while the potter's clay represented the time from Constantine forward which established a Christian Empire. Since the time that Constantine established Constantinople and moved the Roman center of power under the semblance of a Christian kingdom to Constantinople/Byzantium/Roma Nova, a Czar/Tsar had ruled over the east. Even when Constantinople fell to the Ottoman Turks, the Czar's/Tsar's government was moved to Moscow, Russia, the Third Rome, and continued to rule.

The west was basically a different situation. From about the time of Justinian, the Pope of the Roman Catholic Church became empowered and took the authority to crown the western Caesar/Kaiser until this all ended in the "Great War."

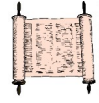
The nations of Europe sought to establish a "League of Nations" to govern the world after WWI, but it failed to materialize until after WWII when the United Nations was established.

As I have revealed in times past, the fulfillment of the Scriptures, "Babylon is fallen, is fallen" came to pass (see Rev. 18:1-2) with the fall of the heads of the Babylonian/Roman kingdoms of east and west in 1914-1918, 2520 years later.

What does Revelation say? <sup>1</sup>"And after these things I saw another angel come down from heaven, having great power; and the earth was lightened with his glory. <sup>2</sup>And he cried mightily with a strong voice, saying, Babylon the great is fallen, is fallen, **and is become the habitation of devils, and the hold of every foul spirit, and a cage of every unclean and hateful bird.**"

This brought about the advent of atheistic socialism, Communism, and humanism which are demonic, devilish, foul, unclean, and hateful.

Furthermore, Jerusalem was destroyed by



Nebuchadnezzar in 587-585 BCE which yields 2520 - 587/585 = 1933-1935, the time of the rising of National Socialism in Germany while Communism had prevailed in the east. Look at the hatred, the demonic, devilish war that came about as a result, hopelessly destroying millions of lives, property, cities, whole countries being fought with the most horrible of weapons. However, our world today is full of weapons, some so horrendous that we don't even know what they are because they are kept secret from the masses.

We are now in the period of the ten toes of the iron (Roman values) and miry clay (demonic socialistic, Communistic, humanistic vanity). ## THE UNITED NATIONS

The United Nations was formed after World War II in order to supposedly bring the nations of the world together into one peaceful body. In reality, it was a deceptive body utilized as a tool to spread socialism and Communism.

Years ago, before we came into the truth of the Sacred Names, we had a minister of the church we were attending who was of Russian descent. In a message he gave at the Feast of Tabernacles in 1986, He held up a replica of the statue placed in front of the UN depicting a man beating a sword into a plowshare. He proudly proclaimed, "This, to me, represents Jesus Christ." I, for one, was dumbfounded. He went on to proudly say that the statue was inspired to be placed there by the atheistic Communist Russians (his people).

They had Isaiah 2:4, "And he shall judge among the nations, and shall rebuke many people: and they shall beat their swords into plowshares, and their spears into pruninghooks: nation shall not lift up sword against nation, neither shall they learn war any more," embossed on the statue.

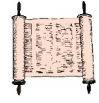
My first question was, "The third commandment states, 'Thou shalt not make unto thee any graven image, or any likeness of any thing that is in heaven above, or that is in the earth beneath, or that is in the water under the earth:'<sup>5</sup>Thou shalt not bow down thyself to them, nor serve them: for I Yahweh thy Elohim am a jealous Elohim, visiting the iniquity of the fathers upon the children unto the third and fourth generation of them that hate me; <sup>6</sup>And shewing mercy unto thousands of them that love me, and keep my commandments,' so why would you relate that to the Savior, isn't this forbidden by the commandment?

My second question was, "The man is naked and the Savior is nowhere revealed to be naked in the Scriptures. Why is he naked?"

My third question was, "This statue is placed in front of an organization formed by men, to trust in men to bring an end to war. How does this relate to the Savior?"

My fourth question/complaint was, “Isn’t it blasphemous to take Scripture and emboss it on a falsified, fake statue made by men, trusting in men to fulfill it when only Yahweh can do so?”

I have since found that the U. N. is an organization established by the international banksters to not only sow the seeds of socialistic Communism, but to bring the whole world under their slavish yoke of bondage. It is a Masonic organization. The Mason’s logo is “Ordo Ab Chao,” (order out of chaos). They create chaos in order to bring a more oppressive system forth for control of the masses (witness the Great Depression). After all, if one is not a Mason, then they are considered to be common and profane.

Recently, it was revealed that this statue, being Masonic inspired, is actually Tubalcain, a Scriptural descendant of Cain who was, “an instructor of every artificer in brass and iron,” Gen. 4:22. He is heralded by the Masons to be the first blacksmith. He, in reality, produced the implements of war made in brass and iron. His name was changed to Balkan/Vulcan by removing the “Tu”, the “B” can be spoken as a “B” or a “V” as in the second Hebrew letter “beit” which can carry either sound.

The “hammer” was his implement (as revealed on the statue) which is proudly exhibited, on the Russian flag, along with the sickle, to this day!

## THE SICKLE

The sickle was an implement of the Roman god Saturn. He was the god of the harvest. Rome, itself, was originally called Saturn and the feast of the Saturnalia, held in what would now be the month of December was the most popular, riotous, orgiastic feast of its time. It has now been reduced to December 25th and called by this new name.

Saturn is the “hidden god” coming originally from the Hebrew word “satr” (סתר). This traces Saturn back to Cain who said, “Behold, thou hast driven me out this day from the face of the earth; and from thy face shall I be **hid**; and I shall be a

fugitive and a vagabond in the earth; and it shall come to pass, that every one that findeth me shall slay me,” Gen. 4:14.

The Hebrew word here is *ehsater* (אֶסְתֵּר). The aleph (א) is a prefix for “I”, *sater* means hid/hidden. To make it into “he is hidden” a waw/vav would be added as a suffix (וְאֶסְתֵּר) which would equal to 666 (ס = 60 + ת = 400 + ר = 200 + ו = 6 = 666).

The sickle would be associated with Cain, the first recorded human murderer, who brought the produce of the earth (a grain offering) which he had proudly grown, but Yahweh expected a blood sacrifice in order to typify the future death of His Son Yahshua, which Abel knowingly provided. Cain was so angry and evidently jealous concerning Yahweh’s acceptance of Abel’s sacrifice and rejection of his own, that he later raised up and slew his brother.

This event is even a most important part of Roman history in the story of the twins Romulus and Remus. Cain slew Abel, was banished from Yahweh’s presence to the land of Nod, the land of wandering. But Cain refused to wander and, instead, built the first recorded city naming it after his son Enoch. Cain was the first Mason and he and his lineage is quite well known and deified by the legends of Freemasonry. Especially, Cain as Saturn, and Tubalcain as Vulcan.

Romulus slew his twin Remus and then built the city of Rome. He was deified by the Romans who not only called the city Rome, but also Saturn.

Thus, Communism is a deification and remembrance of Cain and Tubalcain through the symbols of the hammer and sickle on their flag and monuments.

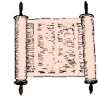

**Experts say the world needs to pick up the pace to achieve the goals by 2030.**

It's not often that politicians all agree on something. But in 2015, leaders from around the world joined together at the United Nations and agreed that we need to take action.

They created a plan to transform the world into one free of poverty and hunger, where every child can go to school, where oceans and forests will be around for future generations to enjoy, and where everyone is equal — all by the year 2030.

In order to realize that vision, **they set 17 goals**, known as the Sustainable Development Goals (SDGs) or Global Goals. And while 17 goals in 15 years certainly sounds ambitious, every one of those goals is crucial to ending extreme poverty by 2030.

The 17 Global Goals — which build off the eight Millennium Development Goals set in 2000

to be fulfilled by 2015 — aim to tackle poverty at its root causes. The goals range from ending hunger and achieving food security to promoting peaceful and inclusive societies.

Each goal is accompanied by several specific targets that hone in on specific strategies to achieve the Global Goals. These include measures like eliminating forced marriage and genital mutilation, increasing the

number of qualified teachers worldwide, and increasing energy efficiency.

The Global Goals call on governments, companies, and everyday citizens to join together to address these economic and social development issues to ensure that everyone has access to

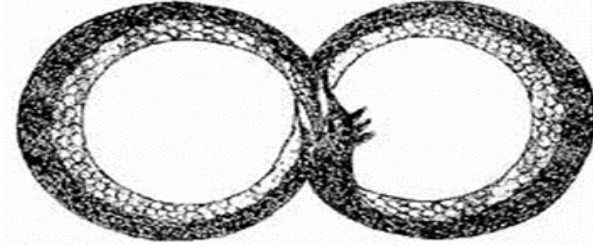
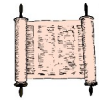
nutritious food, quality health care, education, clean water, and decent paying work.

Look at the image on the previous page which provides icons for the goals. Isn't it interesting that there are 17 goals!? Seventeen yields 153 which is the number of fish caught in the Apostle's net. Look at goal #13. It is the "vesica pisces" (image of the ancient net) while #14 has the fish!

Figure #12 is, in fact, the ouroboros which is a double serpent with its tail in its mouth. In alchemy, the ouroboros represents the spirit of Mercury (the substance that permeates all matter), and symbolizes continuous renewal (a snake is often a symbol of resurrection, as it appears to be continually reborn as it sheds its skin.), the cycle of life and death, and harmony of opposites. A double ouroboros (two creatures swallowing one another) in alchemy signifies volatility. Spiritually, it signifies the balance of the upper and lower natures. (see below)

Finally, #17 represents the “unity,” the finished product of their goal in ensnaring all of the earth. Being five circles with five vesica pisces, five being the number for “grace,” this is their idea of their finished world bestowing their benevolence and grace upon the earth.

Who, in reality, concocted this?

In a related article written by Alex Newman entitled “**UN Agenda 2030: A Recipe for Global Socialism**”

(This was written in January of 2016 while Obama was still president) He writes, “The United Nations and its mostly autocratic member regimes have big plans for your life, your children, your country, and your world. And those plans are not limited to the coercive “climate” agreement recently concluded in Paris.

While the establishment media in the United States was hyping ISIS, football, and of course “global warming,” virtually every national government/dictatorship on the planet met at the 70th annual General Assembly at UN headquarters in New York to adopt a **draconian** 15-year master plan for the planet. Top globalists such as former NATO chief Javier Solana, a socialist, are celebrating the plan, which the summit unanimously “approved,” as the next “Great Leap Forward” — yes, the old campaign slogan of the **Chinese Communist Party**.

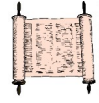
The master plan is comprised of 17 “Post-2015 Sustainable Development Goals” (SDGs) with 169 specific “targets” to be foisted on all of humanity — literally all of it, as the plan itself states explicitly. “As we embark on this collective journey, we pledge that no one will be left behind,” reads the UN manifesto, entitled *Transforming Our World*:

*the 2030 Agenda for Sustainable Development. But if you love liberty, self-government, free markets, or the U.S. Constitution, you will almost certainly be wishing that the UN would leave you behind.*

Officially dubbed “Agenda 2030,” the UN plot, as its full title suggests, is aimed at “transforming” the world. The program is a follow-up to the last 15-year UN plan, the defunct “Millennium Development Goals,” or MDGs. It also dovetails nicely with the deeply controversial UN Agenda 21, even including much of the same rhetoric and agenda. But the combined Agenda 2030 goals for achieving what is euphemistically called “sustainable development” represent previous UN plans on steroids — **deeper, more radical, more draconian, and more expensive.** (NOTE: Who will pay for this expensive plan!? Will it be the earth’s billionaires and trillionaires? The ones who now own close to three quarters of the earth’s wealth? JH)

“This Agenda is a plan of action for people, planet and prosperity,” reads the preamble. “All countries and all stakeholders, acting in collaborative partnership, will implement this plan.” Ironically, the preamble even claims the UN goals will “free the human race from the tyranny of poverty” and “heal” the planet — or, as the planet is also referred to in the document, “Mother Earth.” Not-so-subtly purporting to usurp the role of God, the UN even claimed that the “future of humanity and of our planet lies in our hands.”

Speaking on September 25 at the opening ceremony of the confab that adopted Agenda 2030, Secretary-General Ban Ki-moon hinted at just how far-reaching the plot really is. “The new agenda is a promise by leaders to all people everywhere,” he explained, presumably conflating “leaders” with mass-murdering gangsters such as Kim Jong-un, Raul Castro, Robert Mugabe, and other despots who hold great sway with most of the regimes comprising the United Nations. (NOTE: The mixture of iron and miry clay. JH) “It is a universal, integrated and transformative vision for a



better world.” “We need action from everyone, everywhere,” Ban said, pointing to the “guide” offered by the 17 SDGs (**NOTE:** The net. *JH*). “They are a to-do list for people and planet, and a blueprint for success.” “We must use the goals to transform the world,” Ban continued. “Institutions will have to become fit for a grand new purpose.”

The Agenda 2030 agreement makes the audacity of the scheme clear, too. “This is an Agenda of unprecedented scope and significance,” boasts the document. “Never before have world leaders pledged common action and endeavor across such a broad and universal policy agenda,” the agreement continues. “What we are announcing today — an Agenda for global action for the next fifteen years — is a charter for people and planet in the twenty-first century.”

## The Agenda

Perhaps the single most striking feature of Agenda 2030 is the practically undisguised roadmap to global socialism and corporatism/fascism, as countless analysts have pointed out. To begin with, consider the agenda’s Goal 10, which calls on the UN, national governments, and every person on Earth to “reduce inequality within and among countries.” To do that, the agreement continues, will “only be possible if wealth is shared and income inequality is addressed.” (**NOTE:** Modern day Robin Hood, rob the richer to give to the poorer. Didn’t Yahshua say we would always have the poor with us? Jn. 12:8 *JH*)

As the UN document also makes clear, **national socialism to “combat inequality” domestically is not enough — international socialism is needed to battle inequality even “among” countries.** “By 2030, ensure that all men and women, in particular the poor and the vulnerable, have equal rights to economic resources,” the document demands. In simpler terms, **Western taxpayers should prepare to be fleeced so that their wealth can be redistributed internationally as their own economies are cut down to size by Big Govern-**

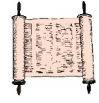
**ment. Of course, as has been the case for generations, most of the wealth extracted from the productive sector will be redistributed to the UN and Third World regimes — not the victims of those regimes, impoverished largely through domestic socialist/totalitarian policies imposed by the same corrupt regimes to be propped up with more Western aid under Agenda 2030.**

Wealth redistribution alone, however, will not be enough. **Governments must also seize control of the means of production — either directly or through fascist-style mandates.** “We commit to making fundamental changes in the way that our societies produce and consume goods and services,” the document states. It also says that “governments, international organizations, the business sector and other non-state actors and individuals must contribute to changing unsustainable consumption and production patterns ... to move towards more sustainable patterns of consumption and production.”

In plain English, the Agenda 2030 document is claiming that today’s “consumption and production” patterns are unsustainable, so we’ll need to get by with less. How much less? It would be hard to find a more clear and concise assessment than that offered by the late Maurice Strong, the recently deceased Canadian billionaire and longtime UN environmental guru who led the 1992 Earth Summit, in a pre-Earth Summit document: **“It is clear that current lifestyles and consumption patterns of the affluent middle-class (NOTE: I wonder why he doesn’t include those of his own status, that is... the super wealthy!? *JH*) ... involving high meat intake, consumption of large amounts of frozen and ‘convenience’ foods, ownership of motor vehicles, numerous electrical appliances, home and workplace air-conditioning ... expensive suburban housing ... are not sustainable.” (NOTE: So, reduce the haves, to the status of the have not’s. Then the world will be reduced to equality in poverty, except for the super rich, of course. *JH*)**

In truth, such “lifestyles and consumption patterns” *are* sustainable, so long as the freedom that makes prosperity possible is not destroyed in the name of achieving “sustainability.” The UN and the environmental lobby claim that we must get by with less because there are now too many people on the planet consuming too many resources. But this [rationale for accepting UN-imposed scarcity is patently false](#).

Of course, the promoters of Agenda 2030 would claim that rather than impoverish us, the global regime they envision would take good care of us — through universal health coverage, for instance. One of the targets for Goal 3, ensuring “healthy lives” and “well-being,” is: “Achieve universal health coverage,” including “vaccines for all.” Universal access to “mental health,” along with “sexual and reproductive health-care services” — **code words for abortion and contraception** — are also included. All governments are expected to integrate such services into their “national strategies and programmes,” the agreement demands.

It is worth noting that **mass-murdering Soviet dictator Vladimir Lenin made clear that controlled healthcare is the “keystone” of socialism**. The United Nations obviously agrees. And though he may not call it “socialism,” Obama undoubtedly also views government control of healthcare as key. Indeed, **enactment of ObamaCare could be viewed as a “great leap forward” by the United States toward implementation of a key component of Agenda 2030, before Agenda 2030 was even “approved.”**

But as important as targeting healthcare is to the globalist schemers, any plan for building international socialism would be lacking without also targeting the next generation with global-socialist propaganda. And so an entire goal of Agenda 2030 is devoted to ensuring that all children, everywhere, are transformed into what the UN calls “agents of change,” ready to push forward the plan for the new global order. “Children and

young women and men are critical agents of change and will find in the new Goals a platform to channel their infinite capacities for activism into the creation of a better world,” the agreement explains.

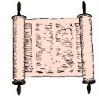
The sort of activists that the UN hopes to make your children into is also explicitly defined in the agreement. “By 2030, ensure that all learners acquire the knowledge and skills needed to promote sustainable development, including, among others, through education for sustainable development and sustainable lifestyles, human rights, gender equality, promotion of a culture of peace and non-violence, global citizenship and appreciation of cultural diversity and of culture’s contribution to sustainable development,” the global plan for 2030 states. Considering what the UN means by “sustainable development” — [population control](#), central planning, global governance, and more — the agenda for your children takes on an even more sinister tone.

**“Sustainable” children for global citizenship in the new order will be accomplished via what the UN misleadingly refers to as “education.”** In the UN document the word “education” alone is mentioned more than 20 times. And throughout the agreement, **the UN openly advocates the use of schools to indoctrinate all of humanity into a new set of values, attitudes, and beliefs in preparation for the new “green” and “sustainable” world order**. The UN’s education agenda also puts sex “education” front and center. “By 2030, ensure universal access to sexual and reproductive health-care services [abortion and contraception], including for family planning, information and education,” the document explains.

How much will Agenda 2030 cost? Various figures have been thrown around by UN bureaucrats regarding the monetary costs of the plan, **generally ranging between \$3 trillion and \$5 trillion per year**.

Yes, *trillions*. In the “From Billions to Trillions” report released by **the World Bank** in July 2015,





the globalist outfit, a key player in Agenda 2030, conceded: “To meet the investment needs of the Sustainable Development Goals, **the global community needs to move the discussion from ‘Billions’ in ODA [Official Development Assistance] to ‘Trillions’ in investments of all kinds: public and private, national and global, in both capital and capacity.**” (NOTE: Who will be in control of all of these trillions? Why, the International Banksters, of course! JH)

But the money needed to implement Agenda 2030 and other UN schemes is only part of the cost. **Other parts include the loss of our national independence and freedom that the rise of global governance and global socialism would surely entail.** Revealingly, empowering dictators to help in global governance is openly touted by Agenda 2030. The document states, “We recommit to broadening and strengthening the voice and participation of developing countries [the regimes ruling those countries] — including African countries, least developed countries, land-locked developing countries, small-island developing States and middle-income countries — in international economic decision-making, norm-setting and global economic governance.”

## Powerful Promoters

When Agenda 2030 was adopted at the 70th annual UN General Assembly confab in New York City on September 25, the UN plot to re-engineer civilization was ushered in with a “thunderous standing ovation,” the UN Department of Public Information reported. 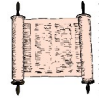
